

TRAIN'SHARE DEBIT/CREDIT CARD CHARGE "AUTHORIZATION"

1. The payment(s) referred to in this Authorization is/are made in connection with a bona fide purchase of Train'Share rights for Journeys by Rail ("Rights") pursuant to provisions of a Train'Share Purchase Agreement and other "Documents" including a Declaration and America's Train Journey by Rail Terms and Conditions, all of which have been received by the undersigned Cardholder(s) ("Cardholder").
2. The undersigned Cardholder acknowledges that tangible delivery of all of the Train'Share Rights being purchased, as referred to in this Authorization, shall be at the time that a Final Sale occurs after a "Waiting Period" and that until that time Cardholder can cancel the Train'Share Rights purchase and receive a refund that includes amounts paid by this Authorization, pursuant to the Purchase Agreement.
3. The undersigned Cardholder(s) agrees that delivery of all of the Rights shall be further evidenced by provision of a Deed of Train'Share Ownership to be issued as provided for in the Train'Share Purchase Agreement and that the place of Rights delivery by the Developer to the Cardholder(s) shall be Fort Worth, Texas, understanding that Journeys by Rail may originate at points throughout the United States.
4. The undersigned Cardholder hereby authorizes ATS to charge a part or the full Train'Share purchase price and fees to the debit or credit card(s) identified below, understanding that they will be processed through a merchant account or comparable system (the "System") as payment for the Rights and that ATS shall hold such funds in a Holding Account to be delivered to Developer only after the Waiting Period and completion of other purchase requirements by the Developer as described in the Purchase Agreement.
5. The undersigned Cardholder acknowledges that he/she/they have had the opportunity to become and are familiar with the circumstances and conditions that are associated with the Train'Share purchase, Journeys by Rail and the Rights for which charges herein are being made.
6. The undersigned Cardholder agrees that at such time as the Rights are delivered, as set forth in section 2. and section 3. above, that amounts paid are deemed to be fully earned by the Developer and that refunds or reimbursements of amounts paid are limited to those described in the Purchase Agreement and Documents.
7. The undersigned Cardholder acknowledges and agrees that the Developer has become obligated to pay costs related to providing Rights because of and starting at the time that the purchase of a Train'Share by the Cardholder(s) is a Final Sale, that subsequent provision of all Rights and related services shall be governed only by the provisions of the Purchase Agreement and Documents, and that all rights of Cardholder to refunds, claims or recourse from or against the Developer or the System and their officers, managers or agents is strictly limited to those expressly set forth in the Purchase Agreement and Documents.
